Written Statement in Response to Questions

- 1) I was actually informed that a vacancy existed on the Hawai`i Teacher Standards Board through one of my professors with the University of Southern California. She put me in contact with a representative of the HTSB who shared information, expectations, requirements, etc. I then consulted with my Complex Area Superintendent (CAS) about the Board as she served as a member until her appointment as CAS. Through this process my interest in serving as a board member grew, and I was humbled that the opportunity presented itself.
- 2) I believe I am qualified to hold a position as a Board member on the Hawai'i Teacher Standards Board given my 14 years of experience as a teacher and administrator in both public and private educational institutions in Hawai`i. - 5) I do not foresee any possible conflicts of interest during my service on the Hawai`i Teacher Standards Board. Should any possible conflicts present themselves, I would either recuse myself from participating in Board decisions or action, or seek to resign my position from the Board to ensure that the public trust is upheld, and the integrity of the board is never diminished.
