## SENATE RESOLUTION

AMENDING RULE 16 OF THE RULES OF THE SENATE OF THE TWENTY-  
SEVENTH LEGISLATURE OF THE STATE OF HAWAII.

1 BE IT RESOLVED by the Senate of the Twenty-seventh  
2 Legislature of the State of Hawaii, Second Special Session of  
3 2013, that the Rules of the Senate of the State of Hawaii, the  
4 Twenty-seventh Legislature, be amended by adding a new paragraph  
5 (6) to Senate Rule 16 Standing Committees to read as follows:

7 "(6) Committee on Hawaiian Affairs. The purview of this  
8 committee includes those programs relating to Hawaiian affairs,  
9 including but not limited to the Office of Hawaiian Affairs,  
10 Hawaiian home lands, sovereignty, and burial councils."; and

12 BE IT FURTHER RESOLVED that the Rules of the Senate of the  
13 State of Hawaii, the Twenty-seventh Legislature, be amended by  
14 deleting paragraph (12) of Senate Rule 16 Standing Committees to  
15 read as follows:

17 ~~"[(12) Committee on Tourism and Hawaiian Affairs. The~~  
18 ~~purview of this committee includes those programs relating to~~  
19 ~~tourism and Hawaiian affairs, including but not limited to, the~~  
20 ~~Hawai'i Convention Center, Hawai'i Visitors and Convention~~  
21 ~~Bureau, the Hawai'i Tourism Authority, the Office of Hawaiian~~

25 BE IT FURTHER RESOLVED that the Rules of the Senate of the  
26 State of Hawaii, the Twenty-seventh Legislature, be amended by  
27 adding a new paragraph (13) to Senate Rule 16 Standing  
28 Committees to read as follows:

30 "(13) Committee on Tourism. The purview of this committee  
31 includes those programs relating to tourism, including but not  
32 limited to the Hawai'i Convention Center, Hawai'i Visitors and  
33 Convention Bureau, the Hawai'i Tourism Authority."; and


1 BE IT FURTHER RESOLVED that the Rules of the Senate of the
