The Board of Directors of the Hawaii State Bar Association (HSBA) appreciates the opportunity to comment on the nomination of Christine E. Kuriyama for the position of Circuit Court Judge, First Circuit.

On October 8th, after learning that Governor Neil Abercrombie had nominated Judge Kuriyama to the bench, the HSBA began its judicial nomination review process. The HSBA membership was notified of the nomination and was asked to comment. Included in this email transmission were the qualification criteria used for the nomination review process: integrity & diligence, legal knowledge & ability, professional experience, judicial temperament, financial responsibility, public service, health, and the ability to fulfill the responsibilities & duties required of the position, the assurance of confidentiality and a deadline to submit their comments no later than October 13th.

Attorneys who submitted less than positive observations were contacted by the Executive Director and were encouraged to provide additional elaboration or clarifying information. These attorneys were again assured of confidentiality unless disclosure of their identity was authorized.

Simultaneous to these actions, I appointed a subcommittee of three (3) HSBA Board members to review the comments received (identifying information is removed unless the attorney authorized disclosure); contact references provided by the nominee and others who have knowledge of the nominee's experience and qualifications; and review documentation provided by the nominee.

I scheduled a Special HSBA Board meeting to review the judicial nominations of Judge Kuriyama, as well as the nominations of Mr. Crabtree and Ms. Masunaga for October 16th and to interview the respective nominees.

On October 16th the full HSBA Board met to review materials submitted by Judge Kuriyama and others as well as documentation prepared by the subcommittee, and to conduct the interview of the Judge.

Taking into consideration all of the information presented by and about the nominee and the interview with the nominee, the Board of Directors of the Hawaii State Bar Association finds Christine E. Kuriyama to be qualified for the position of Circuit Court Judge, First Circuit.

This letter is in support of confirmation of Judge Christine Kuriyama to the Circuit Court of the First Circuit. Judge Kuriyama has been a driving force in successfully establishing the important Honolulu Zero to Three Court for infants and toddlers involved in the child welfare service system. This national model court program was established in 2008 and under Judge Kuriyama's leadership has met its goals very well in the first years. With the loss of federal funding, she helped to move the initiative under the Family Drug Court and obtained a significant three year SAMHSA grant award to continue services.

In addition to her leadership skills, Judge Kuriyama possesses a keen intellect, capacity for attention to detail, and poise under pressure. Perhaps most importantly she has a good grasp of the complex problems involved among those entering the judicial system. I write this letter in support of Judge Christine Kuriyama's nomination for Circuit Court judge of the First Circuit.

I am an attorney licensed to practice law in Hawaii. In the past 15 years I have regularly appeared before Judge Kuriyama in Family Court. Judge Kuriyama has presided on my cases of adoption, divorce, guardianship, Uniform Child Custody Jurisdiction and Enforcement Act, Child Protective Act, and various miscellaneous matters.

Many of these matters have been contested so I have had an opportunity to hear her rulings on evidentiary issues as well her final orders. Judge Kuriyama understands the law and the evidence and issues orders that are consistent with the law and the facts of the matter. She asks questions of the attorneys that sometimes lead us to consider the matter in a different light, often resulting in settlements.

At the risk of sounding sexist, Judge Kuriyama speaks softly and graciously from the bench. This is not to say that she doesn't carry a big stick when required; she is not a pushover in the least. Even at times when a situation has been presented to her in a manner where I was sure any other judge would pull her hair out and stomp off the bench, she has maintained her control and has responded with equanimity.

In a forum where much of our work involves dealing with families who are in the throes of disruption or entirely breaking up, Judge Kuriyama is kind to the litigants before her, whether she rules for or against them.

Judge Kuriyama is a hard worker. On one of my particularly difficult UCCJEA cases, which requires our judge to communicate with a judge of another state, sometimes a state with a 6-hour time difference, Judge Kuriyama exerted great efforts to initiate the communication with, what seemed to me, an uncooperative judge from the other state. She issues orders and decisions immediately from the bench, but when she does not but takes them "under advisement" they are later timely entered.

I have the greatest respect for Judge Kuriyama and wholeheartedly support her nomination for a position as a Circuit Court judge, although it means losing an experienced, hardworking, knowledgeable and kind judge from our Family Court bench.

Dear Senator Hee,

I am writing to you in strong support of confirming Family Court Judge Christine E. Kuriyama as a Circuit Court Judge for the vacancies created by Judge Patrick Border and the now Justice Michael Wilson. I graduated from Punahou School - class of 2005 (with your son Kaʻohu). I am now an attorney and I have been a judicial law clerk at Family Court since December of 2012 and have worked with Judge Kuriyama on various committees and projects (i.e. Juvenile Calendar Revision Committee).

Judge Kuriyama is one of our most experienced judges at Family Court. In March 2014, she received the Outstanding Judicial Achievement Award from the Hawai'i Women Lawyers Organization. Judge Kuriyama was previously a special division judge at family court, handling restraining order cases, paternity cases, guardianship cases, adoptions, and involuntary commitment cases. Judge Kuriyama also runs one of our specialty courts, Zero to Three Court – which is a Child Protective Services court providing services for families with young children where abuse and neglect has been confirmed; helping them work towards reunification and permanence.

In 2014, Judge Kuriyama was recently was appointed as the lead judge of the Domestic Division, which handles all of our divorce proceedings – pre and post decree. Judge Kuriyama has always had a reputation for being fair in her decisions and excelling in keeping an organized flow to her calendar. Whether she is presiding over a criminal or civil case, she always treats attorneys, pro se litigants, and parties with patience and respect.

If you ask any of her fellow Family Court judges, they would tell you that Judge Kuriyama never settles for the status quo – she is always looking to improve and work on new projects to help people in our community. Since she has become lead judge of the Domestic Division, Judge Kuriyama has truly taken charge in turning the division around. By nature, she is very organized, meticulous, and driven. I have no doubt that in running her own Circuit criminal or civil division she would identify the problems or gaps and make sure that the division is running as efficiently as possible.
