The Board of Directors of the Hawaii State Bar Association (HSBA) appreciates the opportunity to comment on the nomination of Michelle Kanani Laubach for the position of Family District Court Judge, Third Circuit.

The HSBA Board of Directors evaluates the qualifications of persons appointed for judicial office, the position of Hawaii U.S. Attorney and the position of Hawaii State Attorney General. We follow a multi-step process to inform the confirming authority of its findings.

- Notification to the nominee of the HSBA appointment review process, which includes a questionnaire requesting educational credentials, legal and other professional work experiences, personal references; a resume; a copy of the JSC application; a form authorizing disclosure from the Office of Disciplinary Counsel of any disciplinary action; and an interview with the HSBA Board of Directors.
- Notification via electronic transmission to the HSBA membership of the appointment and a request for comments on the nominee.
- Appointment of a three-person review Subcommittee of HSBA Board members by the President, which serves as a neutral fact-finding body to review documentation submitted by the nominee, contact references submitted by the nominee, review comments received from the HSBA membership, and conduct follow-up member contact for clarification, if necessary, for presentation to the HSBA Board.
- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.

After the interview of the nominee, which included dialog and questioning relating to her background, experiences, and reasons for pursuing the position of Family District Court Judge of the Third Circuit, the HSBA Board found Ms. Laubach to be **QUALIFIED**.

It is my honor and privilege to present a short Letter of Support on behalf of Appointee Michelle Kanani Laubach.

Just to introduce myself, my background is a humble one, where I am a Hilo / Keaukaha Homestead native, graduated from Hilo High School - (Go Vikings-1977) and University of Hilo - Hawaii in the field of Administration of Justice. I am a retired Sargeant of the Hawaii Community Correctional Center (HCCC) and served from 1985 to 2001, taking an early retirement. I have worked in numerous occupations stemming from loading cargo airplanes, being a bread delivery/salesman, telephone company warehouse man, gas attendant, slack-key guitar instructor, security officer and even a roughneck/laborer drilling for geothermal energy out in the Puna area on the Big island. I am a professional Hawaiian Music Musician and traveled the world abroad spreading the Spirit of "Aloha" through our music. Lastly, like many in our community, I did direct sales and network marketing with a number of companies on a part-time basis making extra income and helping people do the same. I introduce myself this way to share my background and experiences as a person in this, our community here in Hilo, that if you work hard and be a decent person you can do anything and be whatever you want.

Currently, I am a Case Manager with Care Hawaii, Inc's Alcohol and Drug Abuse Division - Integrated Case Management (ADAD-ICM) services for the past ten (10) years now, where I assess, refer, monitor, guide and assist clients who are referred to my Program by the Criminal Justice System (Probation, Parole, and the Dept of Public Safety) to enter drug and alcohol treatment with one of Care Hawaii, Inc's contracted Treatment Provider within the State of Hawaii, and so this is how I have come to know Ms Laubach.

My brief comment will describe the effort(s) I have noticed from Ms Laubach toward and on behalf of her client(s) who had been referred to me for referral and admission into drug and/or alcohol treatment, and therefore was my client also receiving case management services.

It has been my experience that Ms Laubach presented a very active role in her client's case(s) from when the Probation Officer would make the referral (as the client was incarcerated) to Care Hawaii, Inc, to when this Case Manager will be able to place them into treatment in a timely and appropriate manner and thereafter while client remained in case management services. It obviously appeared that she, as their Attorney was very positively interested in their welfare and working on their behalf, as assigned or hired.

Because of lack of funding on some occasion(s) from Case Management Services, Probation or even Treatment, Ms Laubach even helped her client purchase airline ticket(s) to fly from the Big Island to Oahu, where the client had been accepted to enter treatment. She had even made the effort to transport her client(s) from the Hawaii Community Correctional Center (HCCC) down to Hilo International Airport to catch their early flights in the mornings to Oahu and treatment, which is usually (and actually) my responsibility and job description.

Ms Laubach would make intermittent calls to this Case Manager to discuss and review her client's updated status or welfare and followup with treatment counselors to do the same.

Therefore, my brief interactions and communications with Ms Laubach has been nothing short of amazing and professional. I see her as a definite asset and positive enhancement to the judicial community, if chosen to serve as a District Court here in Hilo or anywhere else, and that she would place the client's welfare in a place of "sacredness" until justly proven otherwise, which to me is where our Judicial System's platform or model should strive to rule by.

This is feedback I present to you on behalf of Ms Laubach and confirm this to be true as I close this report.

It is my pleasure to publicly comment on Michele Kanani Laubach, and advocate for her as the Chief Justice's selection for the Third Circuit Family/District Court Judge in Waimea.

I have known Kanani personally and professionally since she came back to Hawaii from Oahu after practicing as a Deputy Prosecuting Attorney for several years in 2006. At first, Kanani and I could be a little adversarial as I was a Criminal Defense Attorney when we first met, and Kanani was a Deputy Prosecuting Attorney for Hawaii County. After we butted heads a few times, I got to know Kanani to be an excellent litigator, who was also very compassionate, and always willing to listen to an alternative point of view. Several times Kanani followed up on information I gave her (asking the police to do further investigation) and we were able to work out reasonable outcomes to many cases. I found Kanani to be a tough but fair Deputy. Prosecutor, and later, after she left the Prosecutor's Office and went into private practice, I found her to be an excellent Criminal Defense attorney. Kanani is tough and fearless in her advocacy for her clients, and has gotten many good results for them. In addition to being a great Criminal attorney, Kanani also has extensive experience in Family Court, which made her stand out from many of the other excellent candidates for the Waimea Court position.

After leaving the Prosecutor's Office, Kanani worked extensively in Family Law, doing divorce and paternity cases, family court TROs, and representing juvenile Defendants. Kanani is the only Waimea Family/District Court candidate I am aware of that has both Family and Criminal Court experience, and she would be able to hit the ground running in Waimea without the need for per diem Judge to pick up the slack. I also know that the Waimea Family Court Judge often has to hear District Court cases, and I think that Kanani's wide breadth of experience would be invaluable. In fact, in addition to her previous Family and Criminal Court expertise, I know that Kanani has also appeared on the District Court civil calendar, doing her own cases and covering for Honolulu attorneys who cannot appear on the Big Island.

Furthermore, Kanani has a professional and educational background in social work (she has an MA from Chaminade University in Counseling) that would be a great benefit to a Family court Judge. In fact, I believe she is the only candidate for this position that has such educational and professional experience. Kanani also has a long history of community service, and is the current Vice-President of the Hawaii County Bar Association, a past member of the Third Circuit Bench Bar Committee, a current member of the State District Court Bench Bar Committee, and along with her partner Dakota Frenz, she basically created an East Hawaii Criminal Defense Bar committee that meets monthly to discuss current issues in the Hawaii County Criminal Bar, disseminate information, advocate for change, and to educate Bar Members. Kanani also volunteers at the Hilo Court self-help center, and is a mother with three children who is active in their educational and extracurricular activities. Kanani also has a very compassionate and good judicial demeanor, and as a colleague and a friend, I believe she would make an excellent Family Court Judge and is the best

choice from the fine list of candidates that the Judiciary Selection Committee put forward to replace Judge Fujino in Waimea, and CJ Recktenwald made the correct choice in picking her.

The bottom line is that Kanani is extremely well qualified for the position as a Family/District Court Judge, and I strongly urge the members you and the members of the Senate Judiciary and Labor Committee to give her your whole hearted support.
