I am writing to express my heartfelt support for the confirmation of my colleague Dakota Frenz to serve as a District Family Court Judge of the Third Circuit. I first met Cody in 2006 when she was a young Hilo prosecutor and I was newly arrived on the Big Island as a forensic psychologist for the Department of Health. Cody and then-District Court Judge Barbara Takase were gracious and supportive in helping me become part of the Hilo Mental Health Calendar, which gave me frequent and regular opportunities to observe what a gifted professional she is. During the past ten years I have had the pleasure (mostly) of working with every Third Circuit prosecutor and public defender involved in cases with defendants for whom mental health issues could potentially affect fitness to proceed and penal responsibility. Most of these attorneys work hard, many of them are quite talented, but if I could pick just one of them to put on the bench for the next twenty years it would absolutely be Cody. She combines two qualities that aren't typically found together, not only in attorneys but in other professions where above-average intelligence is pretty much a given. First, like many attorneys Cody is really, really quick intellectually. Second, she doesn't use that quickness to get by with less work up front; instead, she's also relentless in preparing for cases and ensuring everyone else involved – people like me – is similarly prepared. As an attorney Cody cares about winning but she also cares about moving cases, a quality I particularly admire in judges and one which will serve her and the community well when she is on the bench.

- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.

I am writing to express my strong support and recommendation for the confirmation of the Chief Justice's nomination of Dakota Frenz to the District Family Court bench in the Hilo Division of the Third Circuit. I served as a regular sitting judge in that court from 2008 through my retirement in 2014, and I am presently serving in that court as a *per diem* judge. The Court Transcripts and the language contained therein speaks for themselves in identifying a RICO Enterprise of corrupt public officials, police officers, Judges, Officers of the Court and private citizens involved in an Insurance Extortion Scheme against Senior Citizens in the Puna District, County of Hawaii, State of Hawaii.

If the Senior Citizen did not make the suggested payment then a Traffic Citation was issued and the Courts would find the Senior Citizen to be Guilty where the Senior's Auto Insurance provider would be liable for payment of declared Hit and Run property damages. The Court proceedings of Court No. 3DTC-08-024542 clearly identify how Dakota K.M. Frenz, manipulated the Court Proceedings to confuse the Senior where it is blatantly obvious the Senior Citizen did not have a clue about Court Proceedings and was confused and was vulnerable to judicial abuse. In addition the Senior Citizen Defendant was identified in Court Records in the Court Clerk's Office of the District Courts of the 3rd. I strongly endorse Ms. Frenz' appointment to the position I retired from on August 1st of this year. Cody appeared before me hundreds of times in my nine years on the bench. She was always prepared, always cordial, always willing to work with the opposition while advocating for her client, and always capable of understanding and working with the court's decisions. Cody is and has been for years a hard working and responsible member of Hilo's legal community and the community at large. Of the attorneys who have applied and been appointed recently in the Third Circuit, I cannot think of one I would recommend more highly than Cody Frenz. With his appointment, Chief Justice Recktenwald has given the Big Island the opportunity to have a smart, diligent, competent judge for many years to come.

Based on my experience with Cody in the courtroom and in chambers conferences, I have no questions at all about her integrity. When she represented something to me or to opposing counsel in court or in chambers I had no doubt that those representations were true and complete. Whenever there was a trial or an evidentiary hearing Cody's representations were substantiated. Senator Keith-Agaran and Members of the Senate Judiciary and Labor Committee:

It is my pleasure to comment on Dakota K.M. Frenz's qualifications to serve as Family Court Judge in Hilo. I believe that Chief Justice Recktenwald and the Judiciary Selection Committee made a great choice in selecting her, and that Dakota Frenz would make an excellent Family Court Judge in Hilo.

Cody (as I know her) is a local girl, born and raised in Hilo, and enjoys a great reputation for hard work, diligence, and intelligent and effective advocacy for her clients in the local legal community. She graduated from Waiakea High School, and from the University of Hawaii at Manoa with a Bachelor's Degree in Political Science. She attended Whittier Law School in California, and returned to Hilo to begin her legal career in public service as a Hawaii County Deputy Prosecuting Attorney, where she worked for over six years. Cody was an excellent and fearless Deputy Prosecutor, unafraid to push a case to trial, or settle if the facts and circumstances merited. She has extensive experience working in Family Court criminal matters, and was the primary calendar and trial Deputy Prosecutor working on Family Court Criminal Cases (FC-CR) and Family Court Juvenile Case (FCJ) cases for over three years. She has been in private practice for the last four years doing Criminal Defense, but also extensively worked in Family Court doing TRO hearings, paternity and divorce cases. She has also done some District Court Civil cases.

I have known Cody personally and professionally for over a decade and unreservedly believe that she is highly qualified to serve as Family Court judge and would strongly urge the Senate to confirm her. Using the specific HSBA criteria stated in their request for comments, I would state the following:

Integrity: I believe that Cody is one of the most honest attorneys I have ever dealt with and enjoys a great reputation in the local legal community. When I first met Cody she was a Deputy Prosecuting Attorney and I was a court-appointed Defense Counsel, and on the other side of the aisle. Cody never postured that her cases were better than they really were, nor did she ever lie to me about the availability of her witnesses, and I found her to be one of those attorneys whose word I could trust unreservedly. When Cody crossed the aisle, one of the reasons that she is such an effective advocate is that she continued to display the same level of integrity with her former office.

Diligence: Cody is a very diligent attorney. I have never seen her bounce a hearing date or deadline, and when she was a Deputy Prosecutor, I never knew her to miss a Hawaii Rules of Penal Procedure Rule 48 deadline. When I practiced against Cody, she returned my phone

calls promptly, and followed up on any discovery request I made in a timely manner. I have personally seen her continue to display that level of diligence in her private practice. In fact one of the things that I admire about Cody's criminal practice, (but never did in my own practice) is that she enters every client's phone number in her personal cell phone (and gives them her number). I have seen Cody remind or follow up with her clients to make sure they keep their probation appointments, substance abuse, anger management, or mental health assessments on a regular basis, and have seen them call Cody at irregular hours with their problems, which she promptly responds to.

Legal Knowledge and Ability: Cody is highly intelligent and has the ability to be a great judge. Cody is very familiar with the Family Court, both as a criminal attorney, and also as a family court advocate who has done family court restraining order cases, paternity cases, and divorce cases. If there is any area of Family Court law in which Cody may not have dealt with, her intelligence, common sense, experience and legal acumen will give her the ability to quickly and fairly render a just decision.

Judicial Temperament: I believe that Cody has an excellent Judicial Temperament. I have seen Cody diffuse many potentially difficult situations with defendants, opposing parties and counsel, witnesses and family members without ever raising her voice or disrespecting anyone. I believe that Cody will treat everyone who appears before her with a high level or respect and compassion that would reflect well upon the judiciary and make all those who appear before her feel that their voices have been heard.

Financial Responsibility: While I do not know the intimate details of Cody's personal finances, I have no reason to believe that she is in anyway financially irresponsible.

Public Service: Cody has throughout her career displayed a strong commitment to public service. I know that Cody dreamed of being a Prosecuting Attorney since she was a child, and worked very hard to achieve that goal. While a Deputy Prosecuting Attorney, Cody also served as a board member in the Hawaii County Bar Association, and as a CAAP Arbitrator. When Cody went into private practice, she served as a Kuakahi Mediation Center Board Member, again as a Hawaii County Bar Association Officer and Board Member, a Third Circuit Friends of Drug Court Board Member, a Third Circuit Veteran's Treatment Seminar Committee Board Member, a member of the Third Circuit Bench Bar Committee, a member of the State Bench Bar Conference Criminal section, an arbitrator with the Court Annexed Arbitration Program Mediator, a mediator for the Third Circuit Foreclosure Mediation Pilot Project, and is a regular volunteer at the Hilo Self Help Center. Additionally, along with her former partner Kananai Laubach (now Judge Laubach), Cody basically created an East Hawaii Criminal Defense Committee that meets periodically to discuss current issues in the Hawaii County Criminal Bar, disseminate information, advocate for change, and to educate Bar Members. Cody is also a mother with young two children and is active in their education and extracurricular activities.

Health: While I do not know the intimate details of Cody's personal health, she appears to be very healthy and I have no reason to believe that she could not fulfill her duties as a Judge.

Ability to fulfill the responsibilities and duties of the position: I believe that Cody will make an excellent Judge and for the all the reasons stated above believe that she has a great ability to fulfill the responsibilities and duties of a Judge in the Third Circuit.

Again, I strongly urge the Senate to confirm Cody Frenz to be a Third Circuit Family Court Judge. Thank you for allowing me time to offer my input. Please feel free to contact me anytime if you have any further questions.
