My father received injuries when he was serving in the Marines which resulted in significant mobility issues. As a child I was witness to how difficult it was for him to negotiate his way in the built environment, while also appreciating how simple design changes could have better accommodated his needs.

Everyone should use their skills and career experience to make their communities better.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

To ensure that folks with disability and communication challenges are represented and that their unique needs are considered fairly, especially as the application and interpretation of the Americans with Disabilities Act (ADA) is concerned.

By ensuring that the ADA is fairly implemented and interpreted and that projects funded with tax payer money are ADA compliant.

I have been a licensed Architect for over 20 years and have held licenses in Arizona, California and Hawaii. During that time much of my project experience has been for public sector clients whom are obligated to comply with the requirements of the ADA. While living in California our firm provided third-party access compliance reviews to the Division of the State Architect for K-12 and higher education projects state-wide.

(5) What do you hope to accomplish during your term of service?

I hope to make my contribution by being a fair, reasonable and experienced professional in evaluating Interpretive Opinions regarding ADA access compliance that benefits the consumer, public departments and those responsible for implementing the ADA through their design efforts.
