A BILL FOR AN ACT

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. There is appropriated out of the general
3	revenues of the State of Hawaii the sum of \$250,000,000 or so
4	much thereof as may be necessary for fiscal year 2020-2021 to be
5	deposited into the emergency and budget reserve fund established
6	pursuant to section 328L-3, Hawaii Revised Statutes.
