It is my privilege to write this testimony in support of the confirmation of Gubernatorial Nominee, Clarissa Y. Malinao to the Circuit Court of the First Circuit. I have known Ms. Malinao since 2005, when we met studying for the Hawaii State Bar Exam. We served as law clerks at the First Circuit Court from 2005 to 2006. Afterwards, we worked together for eight (8) years at the State Office of the Public Defender.

Ms. Malinao and I are colleagues at the District Court of the First Circuit, where we have served as per diem judges. It is in this context that I have come to know Ms. Malinao, both professionally and personally. Before being appointed to the bench, Ms. Malinao appeared before me on the Civil Traffic Calendar in 2018. She appeared on behalf of the Volunteer Legal Services of Hawaii ("VLSH"), a non-profit Agency, to assist those indigent and underserved defendants seeking to have their traffic fines converted to re-employment opportunities or community service work. There were many cases on the calendar that morning. But Ms. Malinao handled every case meticulously. She was poised, articulate, passionate and caring about every one of her clients.

Her patience and humble demeanor carries over to the bench. I have observed Judge Malinao preside over the traffic/criminal arraignment, plea and trial calendars, where there could be up to a hundred pro se parties in the morning and/or afternoon session. In spite of the immense pressure to clear the calendar, she is calm and courteous to all litigants and attorneys; yet, able to move the cases in a fast and efficient manner, without compromising the rights and remedies of any party.

Ms. Malinao is a formidable litigator. She has years of state and federal district court trial experience, having particular expertise in the area of criminal defense. She has written appeals and volunteered in the Judiciary's "Courts in the Community Program." The Hawaii Filipino Lawyers Association (HFLA) respectfully submits these comments asking that you consider nominating Clarissa Y. Malinao to the distinguished judicial post on the First Circuit Court.

First, HFLA believes that Clarissa Y. Malinao is an unquestionably qualified candidate of impeccable moral character. She is a woman and a Filipina. As such, she will bring diversity and a fresh, unique perspective to the bench. She is already and undoubtedly putting her vast legal knowledge and experience as a solo practitioner and former Deputy Public Defender into her position as a Per Diem Judge, where she presides over civil matters and petty misdemeanor and misdemeanor criminal trials.

As a solo practitioner, she represents clients at all stages of their criminal proceedings. She represents witnesses before federal grand jury proceedings. She advocates for her clients in family court cases running the gamut – from paternity cases, to contested custody matters, to welfare services, to juvenile and adult Guardian at Litem matters. Before hanging her shingle and opening her solo practice, she was a fierce advocate as a Deputy Public Defender at the Office of the Public Defender. She already has the necessary knowledge, background, and experience to serve as a qualified, well-rounded, and fair Judge on the First Circuit Court. Likewise, she is a long time HFLA member and avid supporter of the Filipino community.

From the district court level on up through our state supreme court, Filipinos are sorely underrepresented on the bench. In district court, Filipinos are the only minority category that is deficient in its representation among judges relative to its proportion of Hawaii's population – where just 3 out of 36 judicial positions are held by Filipinos. In circuit court, that number is 2 out of 30. More significantly, there are no Filipino judges - of the 11 positions at the appellate level - in either the ICA or the Hawaii State Supreme Court. All of this is very troubling when DBEDT shows us that Filipinos represent 20%, when looking at race alone, or 25%, in combination with another race - of Hawaii's population.

Over the years, the Judicial Selection Committee has repeatedly vetted and offered up for your consideration many extremely qualified Filipino candidates for judicial appointments; yet very few have made it to senate confirmation. During your second term, 82% of your appointments went to white or AJA nominees.

It's also worth noting that of Chief Justice Recktenwald's judicial picks over the last eight years, 56% have been women and altogether *mostly* track the ethnic composition of Hawaii's population, except one category - Filipinos.

Given the marked lack of Filipino representation, particularly Filipino women representation, on Hawaii's bench, HFLA would like to emphasize that a decisionmaker's lived experience is integral to responsible, just, and fair jurisprudence. We need a diversity of perspectives to ensure that the contours and context of legally significant facts are given full, and necessary deliberation through lenses that are keen to insidious and systemic injustice – a counterpoint to traditional, more dominant perspectives. This is especially important when so many of the legal

matters that reach our courts, particularly First Circuit Court or even the ICA, disproportionately affect Hawaii's ethnic minorities.

Japanese Americans' legal and historical memory supports this as well. U.S. 9th Circuit Court of Appeals - Senior Judge Atsushi Wallace Tashima had previously described how his life experiences influenced his judicial decision-making— drawing particularly on his family's memory of their incarceration in a World War II U.S. internment camp for Japanese Americans and Japanese immigrants, explaining:

"Because we are all creatures of our past, I have no doubt that my life experiences, including the evacuation and internment, have shaped the way I view my job as a federal judge and the skepticism that I sometimes bring to the representations and motives of the other branches of government."

Promoting greater diversity by nominating Clarissa Malinao will support the legitimacy of our courts; encourage more public confidence in judicial rulings; and case-by-case, right the injustices of our past.

HFLA can attest to Clarissa's commitment to Hawaii's community. Along with juggling work and family, she always finds the time to volunteer and give back to our local community. She serves as a Committee Member on the Access to Justice Commission. She also volunteers for the Family Law Clinic at Volunteer Legal Services of Hawaii. In addition, Clarissa is a long-standing, valued member of HFLA as well as Hawaii Women Lawyers.

Comments: Dear Senate President Kouchi and Members of the Senate: My name is Joan Bird, and I am humbly asking for your support of Ms. Clarissa Y. Malinao by appointing her to be a judge of the First Circuit of the State of Hawai'i. As a domestic violence advocate for over 20 years, I've heard the same complaint from victims of domestic violence that judges don't understand their impact when they make decisions. I've heard the complaint that judges don't understand domestic violence, especially when it is mostly emotional. I've found myself having to continually explain to clients that it isn't because a judge doesn't care, but because they are not educated in domestic violence. The last time I had to say this was yesterday, 10/25/21. When I think about Ms. Malinao, I think about the public defender I met years ago that represented my immigrant client. My client couldn't speak English. Prior to meeting Ms. Malinao my client was afraid of the legal system. When my client was arrested, she was not given an interpreter. She was placed in jail without fully understanding what was happening. My client was charged with a felony when her husband filed a false statement about the incident that happened after she told him that she was leaving him. Her husband used a false report to control her because she stood up to him when he was abusing her. Most attorneys I meet get frustrated with cases that result from domestic violence because of the emotional issues that are part of the victim's experience. I know that it takes patience (of a saint) and listening skills to actively listen to a victim. Some victims "emotionally vomit" all their story because they've held it in for so long. Prior to meeting Ms. Malinao, most of the attorneys I worked with outside of the non-profit I worked with didn't see the need to spend time with an emotional client. I was asked to "hold her hand― and "you deal with her― when a client would be crying. Ms. Malinao was one of the exceptions because she took the time to listen to my client and understand her. Ms. Malinao was able to build and maintain the trust of the client. Ms. Malinao was not afraid to ask questions and learn from other people about domestic violence. Ms. Malinao was down to earth and approachable. Everything that Ms. Malinao did, showed me and my client, that she was there because she cared about the client and her outcome. Ms. Malinao continually showed that she understood that what she did and how the client went through the legal system had real life consequences. Unlike attorneys that just wanted to get the case over with, Ms. Malinao would look beyond the actual case and think about what the consequences would be for the client. Ms. Malinao knew that applying the law had human consequences that affected victims, defendants, and their families. I support Ms. Malinao not because I know her, but because I know her worth as an attorney that understands the impact of decisions made in a court case. I support Ms. Malinao because the Hawai'i State Judiciary needs

more judges that understand domestic violence and the real-life impact that their decisions have outside of the court room. I support Ms. Malinao because I would like to stop having to console clients and explain why a judge didn't understand what their abuser did to them. - Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.
- Meeting of the President, the Executive Director, and the nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board to determine if the nominees is qualified or unqualified.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Ms. Malinao on October 25, 2021 to discuss the subcommittee's findings. On October 26th, Ms. Malinao was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Ms. Malinao was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Ms. Malinao in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Health
- Ability to fulfill the responsibilities and duties of the position

The task of the HSBA was to determine the qualifications and suitability of the Nominee utilizing in large part, the judicial appointments criteria of the American Bar Association. The criteria are not ranked in terms of importance as it is used universally to review the qualifications of appointees for trial and appellate positions. The determination of qualified or unqualified is based on a totality of the documentation received, member and reference comments, and the interview of the individual appointed.

Nominee Malinao currently serves as a Per Diem District Judge for the First Circuit and a solo practitioner. In large part her background as a daughter of immigrants prompted the Nominee to open her law practice in Waipahu in an office space shared with her father, a small business owner for 20 years.

As a solo practitioner since 2015, Ms. Malinao, who is bilingual, represented clients in the State Circuit Court and the Federal Court charged with criminal felony offenses (excluding appeals). She appeared before the Hawaii Paroling Authority and agencies for child welfare proceedings. She also served as Grand Jury Counsel and as a Guardian Ad Litem.

As a Per Diem Judge, Ms. Malinao presided over criminal and civil matters including motions for summary judgement, small claims, and temporary restraining orders. She has also been involved with child and adult Guardian Ad Litem matters.

Prior to her current professional endeavors, the Nominee was a Deputy Public Defender for 8 years. She was assigned to 70 jury trials of which 28 cases (felony and misdemeanor) were tried. In addition, she handled an astonishing number of non-jury trials to completion, argued pretrial motions, prepared appellate briefs, and presented an oral argument before the Hawaii State Supreme Court.

The Nominee is known for her diligence, perseverance, integrity, fairness, respect for the law, and ability to meet challenges. She acquired skills to interact with people firmly and with respect. Her experiences as a litigator and Per Diem Judge will serve her well as a Circuit Court Judge.

Ms. Malinao is a very active member of the Hawaii State Bar Association participating in the Leadership Institute, serving as the current Co-Chair of the Diversity Equality & the Law Committee, and as a Bar representative on the Hawaii Supreme Court's Commission on Professionalism. She has been recognized for her pro bono services to the unserved and underserved.

After a review of all documentation submitted and the interview of the nominee, which included dialogue and questioning relating to her background, experiences, and reasons for pursuing the position of Circuit Court Judge of the First Circuit, the Board of the Hawaii State Bar Association found Ms. Clarissa Y.
