"Long long ago in a galaxy" near to here (Chaminade University), 1987 to 1991, SHANLYN PARK was a student of mine, majoring in English and minoring in Criminal Justice. She was "A plus"! And I was pleased – and honored -- to write a letter of recommendation for Ms. Park supporting her application for admission to the University of Hawaii Richardson School of Law

Even back then, Ms. Park (I shall refer to her as Shanlyn, forthwith) showed the spark and the commitment to public service and community service that brings Shanlyn to this confirmation hearing on her nomination to be a Judge of the First Circuit Court.

It is a pleasure to support the nomination of Shanlyn A.S. Park to be a Circuit Judge of the First Circuit of the State of Hawaii.

I have been practicing law in our State since 1981. I spent more than thirty years as an Assistant U.S. Attorney, during which I handled many cases against Ms. Park. Ms. Park always proved to be a highly ethical and talented attorney who vigorously defended her clients. She was always prepared, carefully reviewed the investigative materials and applicable law, and aggressively litigated issues as appropriate.

I particularly recall one case which involved a defendant who cheated hundreds of families out of their life savings, by falsely marketing a debt elimination program. - Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.
- Meeting of the President, the Executive Director, and the nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board to determine if the nominees is qualified or unqualified.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Ms. Park on October 25, 2021 to discuss the subcommittee's findings. On October 26<sup>th</sup>, Ms. Park was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Ms. Park was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Ms. Park in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Health
- Ability to fulfill the responsibilities and duties of the position

The task of the HSBA was to determine the qualifications and suitability of the Nominee utilizing in large part, the judicial appointments criteria of the American Bar Association. The criteria are not ranked in terms of importance as it is used universally to review the qualifications of appointees for trial and appellate positions. The determination of qualified or unqualified is based on a totality of the documentation received, member and reference comments, and the interview of the individual appointed.

Shanlyn Park is known in the legal community as a criminal and civil litigator who served in the Federal Public Defender's Office for close to 20 years and who has been in the private practice of law for 4 years. During her tenure in the Federal Public Defender's Office, the Nominee represented indigent clients charged with offenses ranging from Class A felonies to misdemeanor offenses, provided comprehensive services to clients from an initial appearance and detention hearings through the trial and sentencing phases, and if necessary, appeals process.

As a private practitioner Ms. Park participated in, and oversaw, all aspects for the defense of claims involving commercial disputes, contested probate matters, insurance claims, and State and federal criminal defense matters.

Ms. Park is known for her integrity, diligence, and trustworthiness. One member reported that with the Nominee "a handshake is enough." Other comments received indicate that Ms. Park has a command of the law and the Rules of Evidence, will be strong, but not disrespectful, and will be fair minded to both sides.

The Nominee's judicial "road map" to listen, identify the issues, research the law, and provide justification for decisions will serve her well as she pursues the next phase of her legal career.

The Nominee currently serves on the Hawaii State Bar Foundation Board and served on the boards of the Legal Aid Society of Hawaii, HUGS, the Sacred Hearts Academy, and the LeJardin Academy Parent Faculty Association.

After a review of all documentation submitted and the interview of the nominee, which included dialogue and questioning relating to her background, experiences, and reasons for pursuing the position of Circuit Court Judge of the First Circuit, the Board of the Hawaii State Bar Association found Ms. Shanlyn A.S. Park to be **QUALIFIED** for the position of Circuit Court Judge of the First Circuit.
