I am a trial attorney practicing in all the courts of Maui County since 1983. I and the two other attorneys in my firm have practiced extensively in front of Judge Kirstin Hamman and we have nothing but the best things to say about her. She is exceedingly bright, has a wonderful judicial manner, remains unruffled in the face of challenging litigants and situations, and while she has been known to be quite tough in her sentences when a criminal defendant deserves it, she listens well to both sides and tempers her judgment with an appropriate degree of compassion. She learned a lot while clerking for former circuit court judge Boyd Mossman and in her career as an attorney, and when she came to the bench several years ago she hit the ground running and she universally commands well-deserved respect from the attorneys who appear before her. She has never shown any bias that I am aware of toward one side or the other, either in general or in any specific case. She is exceptionally well qualified to move up to the Circuit Court bench.

I drafted the following "Petition for Gender Balance in Maui County's Circuit Court," which garnered several hundred signatures of Maui residents including a number of high schoolers, and which was then submitted to Governor Ige during the nomination process. The text of it, reprinted below, makes points which I think are worthy of your consideration during this confirmation process as well.

Petition for Gender Balance in Maui County's Circuit Court

A Petition for Governor Ige

We the undersigned citizens of Maui County respectfully request you as our Governor to appoint a woman to fill the current Second Circuit Court vacancy.

At present Maui has three male and **NO** female Circuit Court judges. Between the Circuit, Family and District Courts – when including both regular and per diem judges – Maui currently has a total of 11 male judges, compared to only 3 female

judges. Among just the full time judges at all levels of our court system, the ratio is almost as bad – only one out of every four judges is female.

Women and girls comprise more than 50% of our community. We understand you have been presented with a list of four applicants for the open Circuit Court judgeship, two male and two female, all of whom have been deemed well-qualified by the Judicial Selection Commission. We respectfully plead with you to ensure some degree of gender balance and equity on our County's most important court, by appointing a woman to the vacant Circuit Court position. Circuit Court appointments last ten years and are almost always renewed. Appointing a fourth man to the Circuit court would most likely "bake in" an all-male bench for a decade or more.

In the court system, which exerts authority and power over our society, it is especially important for women and girls to see themselves. The presence of a female judge would have a significant impact on many women's feelings of belonging, their sense of equality and social status. And the appointment of a female judge would tell bright and capable youth of Maui that they can aspire to a position of great responsibility and honor in our community – regardless of their gender! - Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.
- Meeting of the President, the Executive Director, and the nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board to determine if the nominees is qualified or unqualified.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Judge Hamman on October 25, 2021 to discuss the subcommittee's findings. On October 26th, Judge Hamman was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Judge Hamman was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Judge Hamman in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Health
- Ability to fulfill the responsibilities and duties of the position

The task of the HSBA was to determine the qualifications and suitability of the Nominee utilizing in large part, the judicial appointments criteria of the American Bar Association. The criteria are not ranked in terms of importance as it is used universally to review the qualifications of appointees for trial and appellate positions. The determination of qualified or unqualified is based on a totality of the documentation received, member and reference comments, and the interview of the individual appointed.

Kirstin Hamman dedicated her professional career to public service and the protection of individual civil rights. She has 7 years of experience on the bench, first as a per diem District Court judge and later as a District Court judge of the Second Circuit.

As a per diem judge, the Nominee presided over the District Court traffic, criminal, and civil calendars. As a District Court judge, Judge Hamman presided over District Court traffic, criminal, civil and environmental calendars.

The Nominee was a solo practitioner for 5 years specializing in family law and litigating administrative due process hearings and Federal Court appeals under the Individuals with Disabilities Education Act, Section 504 of the Rehabilitation Act, and American with Disabilities Act.

The Nominee served in the Council Services office for the County of Maui, providing legal services and guidance to County Council's committees and individual Council members. The nominee was also a deputy public defender in the Maui office for close to 10 years. She represented indigent clients during all stages of criminal proceedings, including arraignment and pleas, bail hearings, pretrial conferences, evidentiary hearings, sentencing hearings, bench trials, jury trials, and parole hearings. As an AmeriCorps attorney for the Maui Legal Aid of Hawaii Office, she provided free legal services to low-income families involved with domestic violence issues.

Judge Hamman cares about her community and the practice of law, serving on the Well-Being Task Force, appointed by the Hawaii Chief Justice. As part of the task force, she helped review all aspects of the practice of law, from law school to all areas of employment, to address a national trend of physical and mental challenges, substance abuse issues, and suicide affecting attorneys.

Judge Hamman's passion to help people, and her calm temperament, establish a framework that litigants can understand clearly. Her experience as a per diem judge for 4 years, combined with her 3 years as a District Court Judge presiding over civil and criminal calendars, demonstrates her ability to fulfill the responsibilities of a Circuit Judge.

After a review of all documentation submitted and the interview of the nominee, which included dialogue and questioning relating to her background, experiences, and reasons for pursuing the position of Circuit Court Judge of the Second Circuit, the Board of the Hawaii State Bar Association found Judge Kirstin M. Hamman to be **QUALIFIED** for the position of Circuit Court Judge of the Second Circuit.
