My name is Frederick Macapinlac, I have been a practicing member of the bar in good standing since 2014 and am currently employed by the Office of the Public Defender. My name is Brit Barker and I have been an attorney in the Third Circuit since my first employment at the Prosecutor's Office in March 2014. Even though I live in Kona, most of my current case load is in Hilo. I have had the pleasure of practicing before all the current sitting judges in the Third Circuit, many former and per diem judges, and many different judges in California. From this experience, I believe that many people can qualify to be an appointed judge for the Third Circuit, but not many would be a good fit for the position in its entirety. I truly believe an appointment should be for a judge that is the best for the position. A judge needs to have integrity in answering the needs of the position, hardworking, and supportive of all.

I believe that being a Judge, either in District or Circuit, has many different aspects that not many people fit the role in every way. Some may be excellent in one judicial position but not the other. - Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.
- Meeting of the President, the Executive Director, and the nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board to determine if the nominees is qualified or unqualified.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Judge DeWeese on October 25, 2021 to discuss the subcommittee's findings. On October 26th, Judge DeWeese was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Judge DeWeese was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Judge DeWeese in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Health
- Ability to fulfill the responsibilities and duties of the position

The task of the HSBA was to determine the qualifications and suitability of the Nominee utilizing in large part, the judicial appointments criteria of the American Bar Association. The criteria are not ranked in terms of importance as it is used universally to review the qualifications of appointees for trial and appellate positions. The determination of qualified or unqualified is based on a totality of the documentation received, member and reference comments, and the interview of the individual appointed.

Judge Wendy DeWeese is currently serving a term as a District Family Judge for the Third Circuit. To fulfill the needs of the judiciary and the community, Judge DeWeese has been serving as a Circuit Judge of the Third Circuit on temporary assignment since July 2020. While serving as a temporary Circuit Judge, Judge DeWeese has been called upon to assist with the calendar of the District Family Court as the need arises.

As a Circuit Judge, the Nominee presides over the Big Island Drug Court, the Big Island Veterans' Treatment Court, felony criminal trials, civil cases, including foreclosures, and jury and non-jury trials. As a Family District Judge she presides over a calendar which includes temporary restraining orders, child welfare, paternity and divorce cases as well as regular District Court and Small Claims calendars.

Prior to her appointment to the Third Circuit bench, the Nominee served as a deputy public defender in Kealakekua for over 11 years. She handled all aspects of misdemeanor and felony cases including negotiating plea agreements and contested evidentiary motions. She was also responsible for the juvenile criminal calendar and involuntary hospitalization cases. She also served as the supervising attorney for the Kona Public Defender's Office.

Before moving to Hawaii, Judge DeWeese was a solo practitioner in California. Her law practice specialized in family law, divorce, custody litigation, and mediation. She also was employed in southern California law firms and gained experience in tort law, including insurance settlements, mediation, and arbitration cases.

Judge DeWeese is community oriented. As an avid runner and yoga practitioner, Judge DeWeese was appointed to the Well-Being Task Force by the Hawaii Chief Justice. Her pro bono services prior to her tenure on the bench included the Court Self Help Desk, the Courts in the Community program for high school students, the Kids First program, and the We the People civic education program.

The Nominee's experience as a Per Diem Judge for close to two years combined with her experience of the past 16 months as State Judge presiding over District Family and Circuit Court calendars clearly demonstrate her ability to permanently fulfill the responsibilities of a Circuit Judge.

After a review of all documentation submitted and the interview of the nominee, which included dialogue and questioning relating to her background, experiences, and reasons for pursuing the position of Circuit Court Judge of the Third Circuit, the Board of the Hawaii State Bar Association found Judge Wendy M. DeWeese to be **QUALIFIED** for the position of Circuit Court Judge of the Third Circuit.
