I recently retired after spending 40 years working in the Judiciary, most of it in the courtrooms of the Family and Circuit Courts.

I met Annalisa Bernard when she came to Maui as a Deputy Public Defender. There were a few years that she was assigned to our courtroom in that role, so I got to see her almost daily. I also saw her in court occasionally when she became a Deputy Prosecuting Attorney and a private practitioner.



- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.
- Meeting of the President, the Executive Director, and the Nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board to determine if the nominees is qualified or unqualified.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Ms. Annalisa M. Bernard on August 15, 2022 to discuss the subcommittee's findings. On August 16th, Ms. Bernard was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Ms. Bernard was reviewed and the references listed were contacted for their personal opinions and observations. HSBA members were asked to submit comments based on the following criteria categories:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Ability to fulfill the responsibilities and duties of the position

The task of the HSBA was to determine the qualifications and suitability of the Nominee utilizing in large part, the judicial appointments criteria of the American Bar Association. The criteria are not ranked in terms of importance as it is used universally to review the qualifications of appointees for trial and appellate positions. The determination of qualified or unqualified is based on a totality of the documentation received, member and reference comments, and the interview of the individual appointed.

The nominee, Annalisa M. Bernard, was born and raised on Maui to parents who worked two jobs to provide for their family. Being raised in a close-knit community gave Ms. Bernard a deep appreciation of the culture and history of the Hawaiian plantation era, and of her education at Seabury Hall, Seattle University, and finally at the William S. Richardson School of Law.

Attorneys have described the Nominee as compassionate, diligent, fair, and empathetic. They also note her experience, especially courtroom experience, in criminal law as a former Public Defender and Prosecutor and knows the Rules of Evidence in criminal proceedings. As a private practitioner, the Nominee had gained some civil law experience. It was also noted that Ms. Bernard is calm and even keeled, treats people well, and can resolve situations where people feel they matter.

Ms. Bernard has provided pro bono legal services during her tenure as a government attorney as well as in private practice. The Nominee was active with the Maui County Bar Association, and is active in the Friends of Children's Justice Center, and the Kamehameha Schools Maui campus parent group.

After a review of all documentation submitted and the interview of the Nominee, which included dialogue and questioning relating to her background, experiences, and reasons for pursuing the position of District Court Judge of the Second Circuit, the Board of the Hawaii State Bar Association found Ms. Annalisa Bernard to be **QUALIFIED** for the position of District Court Judge of the Second Circuit.
