My Name is Command Sergeant Major (R) John K. Miyata of 92-6068 Puapake Street, Kapolei, HI. I am currently employed as a Budget Analyst for the U.S. Army and recently retired from the Army Reserves after 36 years of service. It is my honor to have the opportunity to recommend judicial nominee, John Alberto Montalbano. Mr. Montalbano and I have been in acquaintance for the past thirty years and started our young careers together. Through the years I have seen him grow not just as a person but in his career where he dedicated his life to fight for justice and to represent all his clients with the utmost professionalism, commitment and integrity. He has consistently proven himself to be a loyal dedicated Soldier, Attorney and person both in his personal and professional life.

I hope it is clear from his resume that he has the *professional experience* and the *legal knowledge and ability* to do the job. He has a unique set of qualifications and jobs that have trained him to be an excellent Judge.

What I want to talk to you about is what you may not see on his resume. First, he has true *integrity* to do what is right by all he encounters. He is self-less as demonstrated in his personal and professional life. Personally, he is a devoted single father who raised his children and now who helps raise his grandchildren.

Professionally, he has excelled in his military career; as a family law practitioner; and as a *per diem* judge because when Mr. Montalbano sets his mind to do something- he throws himself into it with full commitment and dedication. I recall very early on after he left the Prosecutor's Office he had an interest in Family Law. He followed through on that statement by attending a Family Law seminar where I happened to be one of the instructors. At the time he was working for the civil law firm, yet he went out of his way to sign up for a Family Law class.

Since then, I have had the opportunity to be his opposing counsel and/or co-counsel on cases. I have also been a mediator in his cases. In all those encounters, I have always found him to be first and foremost very attuned to his client. Second, I found him knowledgeable in the law and court procedure. When I became a *per diem* Judge, it was my turn to be the student and him to be my teacher. He graciously walked me through the entire process – from the interview to my first day. I still look to him if I need help or consult. And without hesitation he has always given his time.

His commitment to *public service* is demonstrated in his dedication to serve our country and specifically our State by becoming a *per diem* judge. In addition, Mr. Montalbano volunteers for various pro bono initiatives to promote access to justice. Whatever is asked of him to better serve the public, he gladly agrees to help.

Mr. Montalbano served the military at the same time he was a litigator and a *per diem* judge. This ability to multi-task in very different roles demonstrates he has the judicial temperament necessary for the job. The District Court staff- the bailiffs and court clerks (and even the full-time judges) all respect Mr. Montalbano. This comes from witnessing first-hand his judicial temperament and legal knowledge.

Mr. Montalbano's passion for the law and dedication to public service is exemplified in all he has done. He is extremely qualified for this position. I gladly send in my support of his nomination.

- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.
- Meeting of the President, the Executive Director, and the Nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board to determine if the nominees is qualified or unqualified.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Mr. Montalbano on October 7, 2022 to discuss the subcommittee's findings. On October 11th, Mr. Montalbano was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Mr. Montalbano was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Mr. Montalbano in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Ability to fulfill the responsibilities and duties of the position

The task of the HSBA was to determine the qualifications and suitability of the Nominee utilizing in large part, the judicial appointments criteria of the American Bar Association. The criteria are not ranked in terms of importance as it is used universally to review the qualifications of appointees for trial and appellate positions. The determination of qualified or unqualified is based on a totality of the documentation received, member and reference comments, and the interview of the individual appointed.

John Alberto "Juan" Montalbano has served as a Per Diem District Court Judge for the First Circuit since 2014. His caseload consists of approximately 71% criminal calendar and 29% civil calendar. As a Per Diem Judge, Mr. Montalbano handled personal injury and breach of contract actions under \$40,000, summary possession and damages in landlord tenant disputes, small claims proceedings, requests for civil injunctions, traffic violations, and criminal misdemeanors.

Since 2022 the Nominee has served in the Office of the Command Judge Advocate as a Deputy Command Judge Advocate. In this position, Mr. Montalbano is the alternate legal advisor to the Commanding General, and the primary advisor to the Staff Directorates for personnel, contracting & operations and is the primary action officer with oversight for investigation and prosecution of all sexual assault and sexual harassment cases. He manages and supervises the daily operations for the Office which includes attorneys, paralegals, and other support staff. The Nominee advises Command personnel on administrative law, contracts and fiscal matters, and military justice. He also serves as a Legal Advisor to the Contract Review Board and Ethics Counselor to Department of Defense officers and civilians.

Mr. Montalbano also served in the Career Criminal Unit in the Office of the Prosecuting Attorney for the City and County of Honolulu and was a Circuit Court law clerk. In addition to public service experience, Mr. Montalbano was in the private of practice of law handling: family law cases at trial, mediation, and arbitration; and defended clients in personal injury, products liability including asbestos, and other civil matters.

HSBA colleagues submitted comments on the nomination which include: is respectful of the process, the law, and all the stakeholders; and is always timely with pleadings and responses to opposing counsel.

After a review of all documentation submitted and the interview of the Nominee, which included dialogue and questioning relating to his background, experiences, and reasons for pursuing the position of District Family Court Judge of the First Circuit, the Board of the Hawaii State Bar Association found Mr. John A. Montalbano to be **QUALIFIED** for the position of District Family Court Judge of the First Circuit.
