Chair Rhoads, Vice Chair Gabbard, and members of the Senate Committee on Judiciary:

I respectfully request your favorable consideration of Governor's Message No. 1, appointment of Rebecca Copeland to serve as a Circuit Court Judge in the Circuit Court of the First Circuit (island of O'ahu) State of Hawai'i for a term of ten years.

Judge Rebecca Copeland has been serving as a Family District Court Judge of the First Circuit since January 2020. Prior to that, Judge Copeland served as a per diem district court judge from December 2016 to January 2020. Her dedication to the practice of law, coupled with her trial experience and knowledge of the law are essential qualities in adjudicating cases and fulfilling other responsibilities as a Circuit Court Judge.

Prior to her appointment as a Family District Court Judge, Judge Copeland was an associate with Damon Key Leong Kupchak Hastert, Adjunct Professor at the University of Hawaii William S. Richardson School of Law, and a Deputy Solicitor General with the Department of the Attorney General. These work experiences, coupled with her previous legal experience in the State of Texas make Judge Copeland a qualified appointment to serve as a Circuit Court Judge.

Good Morning Senator Rhoads and Members of the Committee:

Thank you for the opportunity to comment on the nomination of Rebecca Copeland to move up from Family Court to the Circuit Court. I strongly urge your favorable action.

I have known Rebecca Copeland for over 25 years. I first encountered her when I needed help on appeals. Before she became a judge, she was renowned in the Bar as an appellate advocate, and frankly, I think she should skip Circuit Court and go straight to the ICA or the Supreme Court. That said, I have also had many hearings and short trials before her, and she is meticulous in her conduct of proceedings, knows and enforces the rules, and makes reasoned decisions. She has an extremely broad knowledge of the law.

I should also mention that Judge Copeland started the Courts in the Community program prior to her ascension to the bench. In this program, the Supreme Court holds oral argument at local high schools. Volunteer Attorneys meet with classes for two or three sessions beforehand, to teach a little bit of law, explain the case, and preside over students' mock oral argument. I have been one of those volunteers, and it is a great way to slip some civic education into our high school classrooms.

In short, I believe that Judge Copeland will do well on the Circuit Court, and hope that this committee will recommend that the Senate confirm her nomination.

Hawaii Women Lawyers ("**HWL**") respectfully submits testimony in **support** of the nomination of REBECCA COPELAND to the First Circuit Court for a term of 10 years.

HWL is a nonprofit organization of over 350 attorneys whose mission includes improving the status of women in the legal profession, increasing the number of women attorneys in positions of authority and responsibility, and promoting the advancement of all women.

Increasing opportunities for qualified women in the Judiciary is extremely important. As highlighted by the World Justice Project, the rule of law depends on having justice delivered by "competent, ethical, and independent representatives and neutrals who... reflect the makeup of the communities they serve." HWL believes that increasing opportunities for, and improving the visibility of, qualified women in the Judiciary is vital. The judicial bench should be adequately balanced and reflect the composition of Hawaii's citizens. Significant strides have been made in the past several years to improve the diversity of our bench, but HWL believes that more can be done to appoint qualified women to fill judicial vacancies to bring balance to the bench.

Noting that the Hawaii State Bar Association has found Judge Copeland to be qualified for the position of Judge of the First Circuit Court and for the reasons above, HWL supports this nomination.

In addition to her work with the Judiciary's Courts in the Community Program, Judge Copeland has volunteered to participate in JHC's We The People student competition, as well as a number of our public evening programs on a variety of topics. She also is a member of the Judiciary's Commission to Promote and Advance Civic Education. Judge Copeland's willingness to volunteer her time for the Courts in the Community Program, and other Judiciary programs and committees, reflects her passion for and commitment to Hawai'i's justice system. On a personal note, I consider Judge Copeland a friend. Her character is solid. She is kind, honest, compassionate, and fun – and a wonderful parent. 

She possesses a humility and genuine inquisitive approach to her work that serves her extremely well and makes her decision-making capabilities more rounded, informed, and insightful.

- The Executive Director and I met with Judge Copeland on June 19, 2024, to discuss the subcommittee's findings.
- On June 20, 2024, the HSBA Board of Directors interviewed Judge Copeland in an executive session.
- The HSBA Board deliberated and voted that Judge Copeland was qualified.
