

Chair Rhoads, Vice Chair Gabbard and Honorable Committee Members,

I would like to offer my strong support for the consideration and confirmation to the Circuit Court of the First Circuit for Gubernatorial Nominee Steven R. Nichols.

I worked with Mr. Nichols from August 2003 until he left the Office of the Public Defender in \_\_\_ 2023. Mr. Nichols left the office as a supervisor in the Felony Section after having moved through the various sections as a trial attorney. Prior to his promotion to supervisor, Mr. Nichols was a senior felony trial attorney handling the most difficult cases and challenging clients in the circuit court.

Throughout my years at the Office of the Public Defender I have had the opportunity to interact with numerous judges in the district, family, circuit and appellate courts. My experience in working with judges at all levels has given me significant insight into the qualities of a good judge – Mr. Nichols possesses all of those qualities.

One of the most important qualities for a judge is judicial temperament. In all his interactions with outside parties, clients, opposing counsel and the judiciary, Mr. Nichols has exhibited patience, open-mindedness, courtesy, tact, understanding, compassion, humility and common sense. As a senior felony attorney, Mr. Nichols worked on the most serious cases with the most difficult clients and always did so with compassion, integrity and patience.

Another important quality is intelligence. As an appellate attorney and the previous supervisor of the Appellate Section of the Office of the Public Defender I had the opportunity to work with most of the trial attorneys statewide at some point in their careers with the office. Mr. Nichols would always keep abreast of current caselaw and had an excellent legal mind and an acuity for recognizing and analyzing legal and factual issues.

Mr. Nichols' personal and professional ethics, a critical quality for a judge, are also beyond reproach. As a deputy public defender, Mr. Nichols was required to provide his client with constitutionally required zealous advocacy and always did so within the boundaries of professional ethics. Mr. Nichols never cut corners or compromised his personal or professional integrity in the course of his representation of clients.

Mr. Nichols also possesses the courage and integrity required of a judge. Judges must often do what the law requires even though the legally-correct decision is not a popular one. In making their decisions, judges must not be influenced by identity, race, gender, political status, wealth or relationship of the parties or lawyers before the judge. As a criminal defense attorney, Mr. Nichols often had to pursue an unpopular course of action but did so because he was legally and ethically required to do so. Mr. Nichols was never influenced by the personal or social characteristics of his clients. Mr. Nichols had the courage and integrity to provide zealous, competent representation to his clients in conformance with the law and was never influenced by improper considerations.

There are many other characteristics which good judges must possess such as experience, education, a willingness to work hard, the ability to communicate orally and in writing and civil and professional responsibility. As evidenced by his resume and experience, Mr. Nichols possesses all of these qualities.

I unequivocally support Mr. Nichols and respectfully as that this committee confirm his nomination as a judge of the Circuit Court of the First Circuit.

I write in support of my friend and former colleague, Steven R. Nichols, who is a nominee for Circuit Court Judge of the First Circuit. I have known Steve for twenty years, since 2004 back when I was a Deputy Public Defender alongside him for five years.

Having appeared in front of dozens and dozens of judges over my two-decade career, mostly as a public defender in both state and federal court, I believe I have some basis to know what makes a good judge. A good judge that is just, respected by the public and attorneys, and who can move a calendar, are the ones who have compassion, open minds, an ability to quickly grasp the law, and most of all, a firm understanding of how a trial works. It does not matter so much whether a judge comes from a public service background in criminal law, like Steve, or a private background in civil; judges who were trial attorneys by and large simply tend to make good trial judges.

And it is obvious from Steve's resume that he is a remarkably experienced trial attorney. He spent most of his career at the state public defenders. State PDs are some of the best trial attorneys that you will never hear about, most shunning the spotlight and doing an underpaid and underappreciated job. While Steve has been in private practice for a short time now, he still represents indigents clients. He appears day in and day out in state court, fighting to defend the constitutional rights of our citizens.

I will focus on what might not be so apparent from his resume. Steve is one of the most compassionate individuals I have ever met. Many attorneys dislike their clientele or get burned out by their clients' problems. Steve is not like that, even after all these years. He is easygoing, calm and even-tempered, though when he witnesses injustice, he fights hard to correct it. I know that clients always feel like they have a respected and tough advocate in their corner, and they are right.

Steve's resume is limited to mainly criminal cases (although he was recently selected to be a per diem judge). I am sure that is one of your concerns. Steve would have a learning curve with the civil cases, of course, but he is a quick study, bright, curious and unafraid to ask for help. And, the breadth of experience Steve has had in his long tenure at

the Public Defender's would serve him well as a judge. Circuit Court calendars are intense. Trials are grueling. Cases need to get disposed of, but justice needs to be served at the same time. Litigants should be treated with courtesy and respect, even when there is a time crunch, which happens often in court.
